IBU Open Trials (January and February 2020) - Schedule of Play - 3 x 16 board matches against each of the other 2 teams in weekend 1.

To avoid a sit-out we will use an American Whist movement where we score up every 2 rounds (1 Hours and 5 Minutes per 8 board segment).

The top two teams play a 112 board final on Saturday and Sunday 8th and 9th February 2020 in Dublin

Every 4 rounds represents a round robin where each team will have played a 16 board match against the other 2 teams.

Lineups can change between the first and second rounds of each group of 4 rounds but thereafter the third round must duplicate the first round and the fourth round must duplicate the second round.
